Week in Review – announcements and consultations

Enhancing consumer protection in the mortgage market

The Financial Secretary to the Treasury, Mark Hoban, announced <u>a package of measures</u> on 26 January which the government intends will enhance consumer protection in the mortgage market. These measures will:

- transfer the regulation of new and existing second charge residential mortgages from the Office of Fair Trading to the Financial Services Authority, to ensure consistent standards of consumer protection and simplify the regulatory environment for lenders and borrowers;
- ensure consumer protections are maintained when a mortgage book is sold by a mortgage lender to an unregulated firm; and
- extend the current regulation of the sale and rent back market to all providers, to ensure appropriate protection for consumers.

The government has indicated that it expects the FSA to begin working towards implementing these measures immediately, and that the relevant legislation, in the form of statutory instruments, will be published later in 2011.

Independent Commission on Equitable Life Payments' report published

The Independent Commission on Equitable Life Payments, in <u>a report</u> published by Financial Secretary to the Treasury, Mark Hoban, on 26 January, has made the following recommendations for the allocation of funds (amounting to £775 million) to policyholders:

- A pro rata allocation of the available funds, in proportion to the size of relative losses suffered. This equates to 22.4 per cent of non With Profit Annuity policyholders' relative losses.
- A single policyholder view, wherever practicable, offsetting relative gains against relative losses for those that have more than one policy; and
- A minimum amount, in the region of £10, beneath which payments should not be made. This reflects the Commission's view that administering very small payments below this sum would be disproportionate to the administrative costs of making them while being of negligible significance to recipients. The administrative cost of making a payment to those with individual policies is likely to be approximately £10 and may be higher for other policyholders.

- The oldest policyholders, as they are least able to wait for payment and are also least likely to be in a position to
 mitigate the effects of a delay: and
- The estates of deceased policyholders and, as far as possible, the estates of those who die, before receiving a
 payment, in the next three years. This prevents delays to beneficiaries receiving payments when they might be at
 their most vulnerable and reflects the difficulties that could arise from prolonging payments owed to the estates of
 deceased policyholders.

The government has accepted the Commission's recommendations and has said it will publish a scheme design document setting out the practical implications of the recommendations along with other important issues related to the delivery of the scheme, such as the timetable for making payments, and the complaints and challenges procedure. The scheme design document will be made available for Parliamentary scrutiny in the spring.

If the recommendations are implemented, the government expects that around 945,000 policyholders would receive payments equivalent to 22.4 per cent of their relative losses, and that the remaining 100,000 policyholders with relative losses would receive no payment because their pro rata allocation amounts to less than £10.

Review of counter-terrorism powers and legislation published

The Home Office published <u>proposals to amend counter-terrorism powers</u> on 26 January, following a comprehensive review of counter-terrorism powers and legislation which sought to assess whether they were necessary, effective and proportionate. In some areas counter-terrorism and security powers were found to be neither proportionate nor necessary and the recommendations are designed to restore British freedoms while enabling the police and security services to continue to protect the public and national security.

Key recommendations include:

- an end to 28 day detention without charge returning to 14 days as the standard maximum period that a terrorist suspect can be detained before they are charged or released;
- an end to the indiscriminate use of terrorism stop and search powers provided under Section 44 of the Terrorism Act 2000;
- the end to the use of the most intrusive RIPA powers used by local authorities to investigate low level offences and a
 new requirement that all applications by local authorities to use any RIPA techniques are approved by a magistrate;
- a commitment to rationalise the legal basis by which communications data can be acquired and, as far as possible, to limit that to RIPA;
- a stronger effort to deport foreign nationals involved in terrorist activities in this country, while fully respecting human rights obligations;
- the repeal of control orders and their replacement with a more focused and targeted regime which carries
 restrictions similar to powers used in the civil justice system; and
- additional resources to the police and security agencies to underpin the effectiveness of the new regime and the government's commitment to prosecuting wherever possible.

The government said it would renew the current regime until the end of the year in order to allow time for the replacement legislation to be introduced (which it will be in the coming weeks), scrutinised by Parliament and brought into effect.

Reserve legislation is also to be published, but not introduced until necessary, allowing more stringent measures including curfews and further restrictions on communications, association and movement. This would require an even higher statutory test for involvement in terrorism related activity to be met – the balance of probabilities – and the legislation would be introduced to Parliament only when necessary to protect the public from a risk of terrorism.

A report by Lord Macdonald of River Glaven - a summary of the consultation responses and an impact assessment document – was published on the same day.
